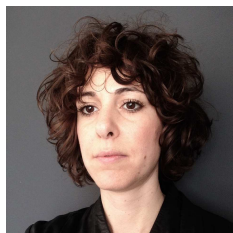

AIKATERINI PAPANIKOLAOU, regular member

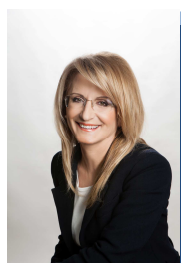
Born in Thessaloniki in 1981. Graduated from 5th high school and went on with her studies at the University of Thessaloniki- Biology department, while attending specialization programs at the University of Macedonia on subjects of economics and management. MSc from University of Piraeus on Health economics, scholarship from Bodossaki institute. She worked in the pharmaceutical industry as specialist and account manager for 7 years. She attended many sales, strategy, marketing seminars and speaker for the Technological Institute of Serres and University of Macedonia as a freelancer.

Gianna Panagopoulou graduated from the Aristotle University of Thessaloniki Law School and she continued with her *post-graduate studies in Penal and Criminal Procedural Law and Criminology*. She further received a scholarship from the Institution of State Scholarships in order to elaborate *her doctoral thesis, focusing on the criminal protection of the environment* and the legal issues that occur while implementing the relevant legislation. Her research was published and she obtained her Ph.D. in 1992.

She has been practicing Law for more than 27 years and she is a lawyer of the Supreme Court of Greece

and of the Council of State.

Since 2002, she has been elected as a member of the *Board of the Bar Association* of Thessaloniki, serving in key positions (twice elected *Vice-President*).
